

MEMORANDUM OF UNDERSTANDING

Between

Faculty of Architecture

Silpakorn University (Thailand)

And

DC Kizhakemuri Foundation (India)

The Faculty of Architecture, Silpakorn University, situated at Phra Borom Maha Ratchawong, Phra Nakhon, Bangkok 10200, Thailand and DC Kizhakemuri Foundation located in DC Kizhakemuri Edam, Good Shepherd Street, Kottayam, Kerala, India, PIN-686001, hereinafter referred to as “the Parties”, have agreed to establish the following Memorandum of Understanding to promote mutual understanding, academic progress, cultural exchange and the collaboration between both Parties.

I

This agreement aims at establishing cooperative relations in the fields of education, research, and other academic exchange programs between both Parties.

II

Both Parties will do their utmost to respect the integrity and independence of each other's institution and to treat each other in equal terms to ensure other's mutual benefits.

III

In order to achieve the purposes mentioned in the preceding two articles, both Parties will strive to realize the following, based on the principles of equality and within the boundary of the legal systems of their respective government.

1. Promote academic and educational exchanges;
2. Exchange lecturers, administrative staff, and students;
3. Support reciprocal visits by professors and researchers;
4. Promote collaboration of research activities of academic staff and students;
5. Implement joint undergraduate, graduate, and internship programs;
6. Seek grants for joint projects;
7. Cooperate to organize symposiums, workshops and conferences;
8. Exchange publications and educational/research materials.

IV

This general Memorandum of Understanding shall be identified as the parent document of any program agreement executed between the Parties. Further agreements concerning any program shall provide details regarding the specific commitments made by each Party and shall not become effective until they have been reduced to writing and executed by the duly authorized representatives of the Parties.

V

The details for implementation of cooperative activities named above will be agreed upon by negotiation between both Parties.

VI

This Memorandum of Understanding will come into effect from the date on which it is formally signed by both Parties and will be effective for a period of 4 (four) years. This Memorandum of Understanding can be amended or nullified by the agreement of both Parties. At the end of each 4-year period, this Memorandum of Understanding will be renewed for successive 4-year period, unless a 6-month advanced written notice of cancellation by either Party is proposed in order to nullify this agreement.

VII

This Memorandum of Understanding is signed in two identical copies in English, of which each Party receives one copy.

ADDENDUM # 1

To

The MEMORANDUM OF UNDERSTANDING dated 22/12/2022

Between

**Faculty of Architecture
Silpakorn University (Thailand)**

And

DC Kizhakemuri Foundation (India)

This addendum # 1 is attached to and regarded as a part of the Memorandum of Understanding date 22/12/2022, between the Faculty of Architecture, Silpakorn University, Thailand and DC Kizhakemuri Foundation, India. The terms and additional conditions are as follows:

Article 1: Intellectual Property

The intellectual property rights, in which the persons participating in the exchange appear as inventors or authors, shall be the property of the universities/institutions involved in accordance with the contributions made and, in all instances, in accordance with the stipulations set forth in the corresponding specific agreement in which ownership and exploitation of the results shall be determined.

Article 2: Data Protection

Both the institutions agree to abide by current legislation in the matter of protection of data of a personal nature established for said purpose in each country.

Article 3: Dissemination and Advertising

Both the institutions agree to include their respective logos in any and every medium, platform or document which makes reference to their joint activities. Signing the present agreement serves as authorisation from the respective institutions for the same.
