Sub: Re-constitution of Anti Ragging committee

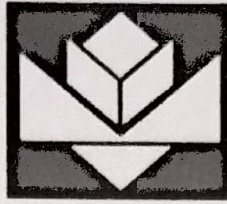

At the DC School of Architecture and Design, a zero-tolerance policy towards ragging is rigorously enforced. Aligning with University Grants Commission Act and AICTE guidelines, the administration implements stringent measures to eradicate ragging completely.

The primary objectives of the anti-ragging committee in DC School of Architecture and Design are as follows:

- **Prevention:** Implement proactive measures to prevent any form of ragging within the institution, including awareness campaigns, strict disciplinary actions, and regular monitoring of student interactions.
- **Support:** Provide comprehensive support systems for victims of ragging, including counseling services, confidential reporting mechanisms, and avenues for seeking assistance and protection.
- **Education:** Foster a culture of respect, empathy, and inclusivity through educational initiatives aimed at sensitizing students about the harmful effects of ragging and promoting positive peer interactions.
- **Enforcement:** Enforce strict adherence to anti-ragging policies and regulations, ensuring swift and impartial action against perpetrators to deter future incidents and uphold a safe and conducive learning environment for all.

Plan of Action:

- ⊙ *Awareness Campaigns: Launch a series of awareness campaigns targeting both students and staff to educate them about the negative consequences of ragging. These campaigns can include posters, workshops, seminars, and orientation sessions at the beginning of each academic year.*
- ⊙ *Training and Workshops: Conduct training sessions and workshops for faculty, staff, and student leaders on identifying, preventing, and addressing instances of ragging. Equip them with the necessary skills and knowledge to effectively intervene and support victims.*
- ⊙ *Establishment of Anti-Ragging Committees: Set up dedicated committees comprising faculty, staff, and student representatives to oversee the implementation of anti-ragging policies. These committees will be responsible for receiving complaints, conducting investigations, and taking appropriate disciplinary actions against offenders. Regular meetings and follow-ups will ensure the proactive management of ragging-related issues.*


